

Our privacy policy

Our website is operated by Rowley's Gin Bar Derby. We take your privacy very seriously therefore we urge to read this policy very carefully because it contains important information about on:

-) who we are,
-) how and why we collect, store, use and share personal information,
-) your rights in relation to your personal information, and
-) how to contact us and supervisory authorities in the event that you have a complaint.

Who we are

Rowley's Gin Bar Derby, we collect, use and are responsible for certain personal information about you. When we do so we are regulated under the General Data protection Regulations which apply across the European Union (including the United Kingdom) and we are responsible as 'controller' of that personal information for the purposes of those laws.

The personal information we collect and use

a) Personal information you provide to us

b) Personal information you provide about third parties

shall consent on their behalf to the transfer of their personal data abroad.

How we use your personal information

How long your personal information will be kept

We will hold your personal information for the following periods:

Reasons we can collect and use your personal information

We rely on the following as the lawful basis on which we collect and use your personal information:

Consequence of our use of your personal information

The consequence to you of our use of your personal information is:

Your name, email address and phone number where provided is kept on our data base for the sole purpose of contacting you. It is not shared with a third party.

Keeping your information secure

We have appropriate security measures in place to prevent personal information from being accidentally lost, or used or accessed in an unauthorised way. We limit access to your personal information to those who have a genuine business need to know it. Those processing your information will do so only in an authorised manner and are subject to a duty of confidentiality.

We will also use technological and organisation measures to keep your information secure. These measures may include the following examples:

Information we keep is secured on our cloud based contact list.

We also have procedures in place to deal with any suspected data security breach. We will notify you and any applicable regulator of a suspected data security breach where we are legally required to do so.

Indeed, while we will use all reasonable efforts to secure your personal data, in using the site you acknowledge that the use of the internet is not entirely secure and for this reason we cannot guarantee the security or integrity of any personal data that are transferred from you or to you via the internet. If you have any particular concerns about your information, please contact us using the details below.

Transfers of your information out of the EEA

We will not transfer your personal information outside of the EEA at any time.

What rights do you have?

Under the General Data Protection Regulation you have a number of important rights free of charge. In summary, those include rights to:

-) fair processing of information and transparency over how we use your use personal information
-) access to your personal information and to certain other supplementary information that this Privacy Notice is already designed to address
-) require us to correct any mistakes in your information which we hold
-) require the erasure of personal information concerning you in certain situations
-) receive the personal information concerning you which you have provided to us, in a structured, commonly used and machine-readable format and have the right to transmit those data to a third party in certain situations
-) object at any time to processing of personal information concerning you for direct marketing
-) object to decisions being taken by automated means which produce legal effects concerning you or similarly significantly affect you
-) object in certain other situations to our continued processing of your personal information
-) otherwise restrict our processing of your personal information in certain circumstances
-) claim compensation for damages caused by our breach of any data protection laws

How to complain

The General Data Protection Regulation also gives you right to lodge a complaint with a supervisory authority, in particular in the European Union (or European Economic Area) state where you work, normally live or where any alleged infringement of data protection laws occurred.
